Resolution No. K-2013-002

A RESOLUTION RECOMMENDING THE APPROVAL OF THE THIRD SUPPLEMENTAL PROCUREMENT PLAN (AMENDATORY APP NO. K-APP - 2013-S3) FOR THE BUDGET 2013

Presented for approval before the members of the Bids and Awards mmittee the RECOMMENDATION FOR APPROVAL OF THE THIRD PPLEMENTAL PROCUREMENT PLAN (AMENDATORY APP NO. K - APP-2013-S3) R THE BUDGET 2013, to wit:

WHEREAS, it is stipulated in Section 7.1 of the Revised IRR of Republic Act No. 9184 that "All procurement shall be within the approved budget of the procuring entity and should be meticulously and judiciously planned by the procuring entity. $x \times x$;"

WHEREAS, it is stipulated in Section 7.3.5 of the subject IRR that "(A)s soon as the x x appropriation ordinance, x x becomes final, the end-user units shall revise and adjust the PPMP to reflect the budgetary allocation for their respective PAPs. The revised PPMPs shall be submitted to the BAC, through its Secretariat, for the finalization of the modes of procurement under the proposed APP. The APP shall then be approved in accordance with Section 7.2 of this IRR;"

WHEREAS, it is stipulated in Section 7.2 of the subject IRR that "(N)o procurement shall be undertaken unless it is in accordance with the approved APP of the procuring entity. The APP shall bear the approval of the Head of the Procuring Entity or second-ranking official designated by the Head of the Procuring Entity to act on his behalf, and must be consistent with its duly approved yearly budget;"

WHEREAS, it is likewise stipulated in Section 7.4 of subject IRR that "(U)pdating of the individual PPMPs and the consolidated APP for each procuring entity shall be undertaken every six (6) months or as often as may be required by the Head of the Procuring Entity. The updating of the PPMPs shall be the responsibility of the respective end-user units of the Procuring Entities, while the consolidation of these PPMPs into an APP shall be lodged with the BAC Secretariat, subject to approval of the Head of the Procuring Entity."

WHEREAS, this THIRD SUPPLEMENTAL Amendatory APP also contained the items for amendment that were submitted by the end-users for proper procurement process indicated as Supplemental APP No. K-APP-2013-S3, a copy of which is attached hereto and made as an integral part hereof;

WHEREFORE, after careful deliberations and study of the matter, the Bids and Awards Committee resolved to recommend the approval of the RECOMMENDATION FOR APPROVAL OF THE THIRD SUPPLEMENTAL PROCUREMENT PLAN (AMENDATORY APP NO. K – APP-2013-S3 FOR THE BUDGET 2013;


