APPROPRIATION ORDINANCE NO. 36
SERIES OF 2012

AN ORDINANCE APPROPRIATING THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (PHP 400,000.00) FOR THE PAYMENT OF EXPENSES TO BE INCURRED UNDER "GASOLINE, OIL AND LUBRICANTS EXPENSES" UNDER THE BUDGET OF THE SANGGUNIAN PANLUNGSOD AND THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (PHP400,000.00) FOR THE PAYMENT OF EXPENSES TO BE INCURRED UNDER "GASOLINE, OIL AND LUBRICANTS EXPENSES" UNDER THE BUDGET OF THE VICE MAYOR'S OFFICE, CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2012.

WHEREAS, submitted for review and approval is the proposed re-alignment of funds under "Travelling Expenses" and "Other Maintenance and Operating Expenses" in the Office of the Sangguniang Panlungsod and Office of the Vice-Mayor covered by the Annual Budget for CY 2012;

WHEREAS, the funds to be re-aligned shall no longer be used for the Office of the Sangguniang Panlungod's budget under "Travelling Expenses" and the Office of the Vice-Mayor's budget under "Other Maintenance and Operating Expenses" considering that there are sufficient available funds to finance the operating expenses of the said offices;

WHEREAS, there is a need to re-align the amount of Four Hundred Thousand Pesos (PhP 400,000.00) from the "Other Maintenance

and Operating Expenses" of the Vice Mayor's budget and Four Hundred Thousand Pesos (Php400,000.00) from the "Travelling Expenses" of the Sangguniang Panlungsod's budget to "Gasoline, Oil and Lubricants Expenses", to wit:

NOW THEREFORE:

BE IT ORDAINED AS IT IS HEREBY ORDAINED, by the Sangguniang Panlungsod of Bacoor, Cavite, in regular session assembled upon motion of Councilor Reynaldo Palabrica to approve the re-alignment of funds under the Sangguniang Panlungsod's budget for "Travelling Expenses" to "Gasoline, Oil and Lubricants Expenses" and the Vice-Mayor's Office budget for "Other Maintenance and Operating Expenses" to "Gasoline, Oil and Lubricants Expenses" as indicated above covered by Annual Budget for CY 2012.

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that :

Section 1. The purpose of this Ordinance is to appropriate the amount of Four Hundred Thousand Pesos (Php 400,000.00) and Four Hundred Thousand Pesos (Php400,000.00) or so much thereof as may be necessary for the "Gasoline, Oil and Lubricants Expenses" under the budget of the Office of the Sangguniang Panlungsod and the Office of the Vice Mayor respectively for Calendar Year 2012;
