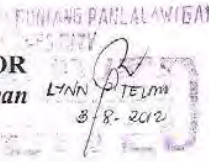

MUNICIPAL ORDINANCE NO. 4
SERIES OF 2012

Introduced by Hon. Reynaldo M. Fabian

AN ORDINANCE MANDATING OBSERVANCE BY TOP CORPORATIONS OPERATING IN BACOOR, CAVITE OF THEIR CORPORATE SOCIAL RESPONSIBILITY WITHIN THE MUNICIPALITY.

Explanatory Notes

WHEREAS, the Local Government of Bacoor, Province of Cavite recognizes the vital role of the private sector in the delivery of basic services to the people of the Municipality;

WHEREAS, it is the avowed policy of the Local Government of Bacoor to encourage the participation of the private sector in local governance, particularly in the delivery of basic services, to ensure the viability of local autonomy as an alternative strategy for sustainable development;

WHEREAS, to provide a mechanism for private sector participation in local governance and the delivery of basic services, the Local Government of Bacoor deems it fit and proper to institutionalize Corporate Social Responsibility.

NOW, THEREFORE

BE ORDAINED BY THE MUNICIPAL COUNCIL OF BACOOR, CAVITE IN REGULAR SESSION ASSEMBLED, THAT:

SECTION 1. Short Title.—This ordinance shall be known as the “*Bacoor Corporate Social Responsibility Ordinance of 2012.*”

SECTION 2. Corporate Social Responsibility.—Any corporation, partnership and other business establishments operating and/or doing business within the Municipality of Bacoor and covered by this Ordinance are hereby mandated to observe its corporate social responsibility within the territorial jurisdiction of the Municipality of Bacoor, Province of Cavite.

SECTION 3. Coverage.—This Ordinance shall apply to the following corporations, partnerships or business establishments:

1. Top 200 business taxpayers of the previous year, as certified by the Officer-in-Charge of the Business Permit and Licensing Office (BPLO);
2. Real estate developers;
3. Banks and other financial institutions;
4. Utilities, such as but not limited to, Maynilad, Meralco and PLDT.

SECTION 4. Periodic Report. — All corporations, partnerships and other business establishments covered by this Ordinance shall submit to the BPLO an annual report relative to their compliance of the provisions of this Ordinance for

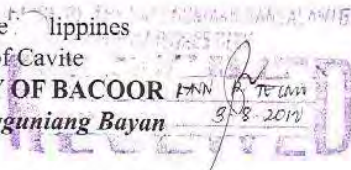

the preceding year, together with their proposed activities to implement the provisions of this Ordinance for the current year, not later than January 31 of each year.

SECTION 5. Implementing Office --- The Business Permit and Licensing Office of the Municipality is hereby tasked to implement the provisions of this Ordinance.

SECTION 6. Implementing Rules and Regulations. -- The Municipal Mayor may, from time to time, issue rules and regulations he may deem fit and necessary for the effective implementation of this Ordinance.

SECTION 7. Effectivity.--- This ordinance shall take effect upon its compliance with the requirement of the law on posting, publication and public hearing.
