ORDAINED MOREOVER, that the Sangguniang Panlungsod shall appropriate the necessary funds in the Supplemental Budget No. 2 for Calendar Year 2013 of the City Government of Bacoor to cover the salaries and other benefits of the employees who will be appointed to the positions above-mentioned.


ORDAINED FURTHER, that this Ordinance shall take effect upon its posting in at least two (2) conspicuous places within the City of Bacoor.

ORDAINED FINALLY, that the Civil Service Commission, City Budget Office, Office of the City Mayor and the Human Resources Development and Management Department (HRDMD) be furnished copies of this Ordinance.
