PALABRICA unanimously seconded by the Sangguniang Panlungsod in its 5<sup>TH</sup> regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of Bacoor, Province of Cavite to approve the Ordinance ratifying the Memorandum of Agreement executed by the City of Bacoor and the Department Of Public Works and Highways (DPWH) on the Slope Protection Project.
