- REAL I- Two Hundred Twenty Six Thousand Five Hundred Sixteen Pesos and 23/100 (Php226,516.23) (Please see attached Barangay Resolution and Appropriation Ordinance);
- ZAPOTE I One Hundred Fourteen Thousand One Hundred Ten Pesos and 80/100 (Php114,110.80) (Please see attached Barangay Resolution and Appropriation Ordinance);

WHEREFORE, after thorough deliberation on the aforementioned barangay budgets, the Sangguniang Panlungsod on its 6th regular session assembled, HEREBY ORDAINED AS IT IS HEREBY ORDAINED, to approve the Supplemental Appropriation of Barangays Molino V, Salinas IV, Salinas II, Real I and Zapote I provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangays mentioned above and on two (2) other conspicuous places within the City of Bacoor.
