AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY MOLINO II IN THE CITY OF BACOOR.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of barangay Molino II, in the amount of Four Hundred Seventy Nine Thousand Eight Hundred Twenty Nine Pesos and 90/100 (Php 479,829.90). Attached are the Barangay Resolution No. 02-2013 and appropriation Ordinance No. 02-2013 Series of 2013 dated July 15, 2013.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive and others concerned for their information and guidance.





