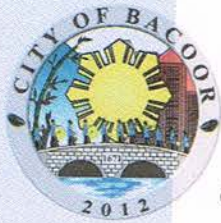

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriation of barangay Habay I in the amount of Five Hundred Seventy Thousand Pesos (Php570,000.00).
