A CITY ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 14, SERIES OF 2010, ENTITLED, "AN ORDINANCE REQUIRING THE QUARTERLY CALIBRATION INSPECTION AND SEALING OF ALL WEIGHING SCALES AND FUEL PUMPS/HOSES OPERATING WITHIN THE MUNICIPALITY OF BACOOR, CAVITE, THE IMPOSITION OF A FIXED CALIBRATION INSPECTION FEE, AND THE IMPOSITION OF PENALTIES FOR VIOLATIONS HEREOF".

WHEREAS, there is a need to amend pertinent provisions of various municipal ordinances such as Municipal Ordinance No. 14-S-2010 pursuant to the ratification of Republic Act No. 10160 on June 23, 2012 converting Bacoor into a component city of Cavite;

NOW, THEREFORE, during regular session assembled, upon motion of Councilor Reynaldo D. Palabrica duly seconded by Councilor Hernando C. Gutierrez **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod to amend various sections of this Ordinance to read as follows, to wit:

Section 1. The following provisions of Municipal Ordinance No. 14-S-2010 are hereby amended and shall henceforth read as follows:

X X X X X

Section 2. Scope. – This Ordinance shall cover all weighing scales used to weigh various goods and commodities and fuel pumps/hoses being operated by all business establishments within City of Bacoor, Cavite.

Section 3. Calibration inspection/Calibration Inspection Fee. – A calibration inspection of all weighing scales and fuel pumps/hoses covered by this Ordinance shall be conducted by the Business Permits and Licensing Office (BPLO) and by the Office of the City Treasurer once every two (2) months of every year following the approval hereof. The following calibration inspection fees will be charged against the owners/operators of all weighing scales and fuel pumps covered by this ordinance, to wit:

- 3.1 weighing scales that measure loads not exceeding 50 kgs. – P 50.00 per scale per quarter.
- 3.2 weighing scales that measure loads 50 kgs. Or heavier – P 75.00 per scale per quarter.
- 3.3 Fuel pumps regardless of the type of fuel it dispenses – P 100.00 per pump per quarter.

The above-mentioned fees shall be collected every quarter by the City Treasurer from the owners, operators, managers, or officers-in-charge of all business establishments covered by this ordinance.

Section 6. Penalties. – Any person who violates this Ordinance shall be punished in the following manner:





OFFICE OF THE SANGGUNIANG PANLUNGSOD

a. For removing or tampering of seal:

First Offense: payment of fine of P 1,500.00;

Second Offense: payment of fine of P 2,000.00;

Third Offense: payment of fine of P3,000.00 plus imprisonment of not more than six (6) months.

b. For using a weighing scale or fuel pump/hose that has not been inspected and/or sealed:

First Offense: payment of fine of P 1,500.00 plus confiscation of weighing scale or fuel pump/hose;

Second Offense: payment of fine of P 2,000.00 plus confiscation of weighing scale or fuel pump/hose;

Third Offense: payment of fine of P 3,000.00 plus confiscation of weighing scale or fuel pump/hose and cancellation of business permit, if any.

c. For using a miscalibrated weighing scale or fuel pump/hose regardless of the degree of inaccuracy

First Offense: imprisonment for not more than two (2) months plus fine of P 1,500.00;

Second Offense: imprisonment of not more than four (4) months plus fine of P 2,000.00;

Third Offense: imprisonment of not more than six (6) months plus fine of P 3,000.00.

Section 8. Administrative Liability. – Any **city employee** who violates this Ordinance by either (a) failing to issue an official receipt to the owner, manager, supervisor, or officer-in-charge of the business establishment concerned, (b) failing to seal the weighing scales or fuel pumps/hoses concerned, (c) making an incorrect assessment of the amount of calibration inspection fee to be collected from the business establishment concerned, (d) failing to inspect a business establishment within the period specified in this Ordinance without just cause, or (e) by committing any other act analogous to the foregoing shall be held administratively liable and maybe punished in accordance with applicable civil service rules".
