AN ORDINANCE RE-ALIGNING THE AMOUNT OF ONE MILLION ONE HUNDRED THOUSAND PESOS (PHP 1,100,000.00) FROM THE SAVINGS OF "SALARIES" OF UNFILLED THREE (3) SANGGUNIANG PANLUNGSOD MEMBERS POSITIONS (SECTORAL REPRESENTATIVES) FOR THE PAYMENT OF EXPENSES TO BE INCURRED UNDER "SALARIES AND WAGES" OF PUBLIC SERVICE COORDINATORS UNDER JOB ORDER STATUS IN THE BUDGET OF THE SANGGUNIANG PANLUNGSOD, CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2013.

WHEREAS, there is a need to re-align the amount of One Million One Hundred Thousand Pesos (PhP 1,100,000.00) from the Savings of "Salaries" of unfilled three (3) SP Members positions (Sectoral Representatives) of the Sangguniang Panlungsod's budget to "Salaries and Wages" of Public Service Coordinators, to wit

I. SOURCE OF FUND:

NOW THEREFORE, upon motion of Councilor Reynaldo Palabrica unanimously seconded by all the councilors present in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the re-alignment of funds under the Sangguniang Panlungsod's budget from the savings of "Salaries" of unfilled three (3) SP Member Positions (Sectoral Representatives) to "Salaries and Wages" of Public Service Coordinators covered by Annual Budget for CY 2013.

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that :

Section 1. The purpose of this Ordinance is to appropriate the amount of One Million One Hundred Thousand Pesos (PhP 1,100,000.00) for the "Salaries and Wages" of Public Service Coordinators under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2013;

Section 2. The above-mentioned amount of One Million One Hundred Thousand Pesos (PhP 1,100,000.00) shall be re-aligned from the savings of "Salaries" of unfilled three (3) SP Member Positions (Sectoral Representatives) under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2013;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. This Appropriation Ordinance shall take effect upon its approval.
