
## CITY ORDINANCE NO. 2013-053 Series of 2013

# AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY ANIBAN II IN THE CITY OF BACOOR.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriation of barangay Aniban II, in the amount of One Hundred Sixty One Thousand Two Hundred Forty Pesos and 49/100 (Php 161,240.49). Attached is the Barangay Resolution No. 02-2013 and Appropriation Ordinance No. 02-2013 Series of 2013 dated September 16, 2013.
