Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriation of barangay Aniban II, in the amount of One Hundred Sixty One Thousand Two Hundred Forty Pesos and 49/100 (Php 161,240.49).
