AN ORDINANCE OFFICIALLY DESIGNATING THE NEWLY-CONSTRUCTED PUBLIC ELEMENTARY SCHOOL BUILDING AT MALIPAY PHASE 3, MOLINO 4, BACOOR CITY, CAVITE AS THE "REVILLA ELEMENTARY SCHOOL".

WHEREAS, the City Government have recently completed the construction of a brand new public elementary school in Malipay Phase 3, Molino 4, Bacoor City, Cavite under the City of Bacoor's education program.

WHEREAS, there is a need to give the said newly-constructed building an official designation in order to avoid confusion pursuant to the provisions of Section 13 of Republic Act No. 7160 (also known as the "Local Government Code of 1991")

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod in special session duly assembled THAT:

Section 1. The newly constructed public elementary school at Malipay Phase 3, Molino 4, Bacoor City, Cavite is hereby officially named, as per the recommendation of the Local School Board, as the "Revilla Elementary School" in honor of the Revilla family which has consistently championed the interests of the people of the City of Bacoor and of the Province of Cavite.

Section 2. All ordinances, rules and regulations, or parts thereof, in conflict with, or is inconsistent with any of this Code are hereby repealed or modified accordingly.

Section 3. This Ordinance shall become effective upon completion of its posting in at least (3) three conspicuous places in the City of Bacoor, Cavite pursuant to Sections 59 and 188 of R.A. 7160, the Local Government Code of 1991.

ENACTED by the Sangguniang Panlungsod of the City of Bacoor this $23^{\rm rd}$ day of December 2013.
