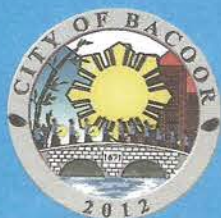

- Aniban III – Ninety Three Thousand Two Hundred Seven Pesos and 69/100 (Php93,207.69) (Please see attached Barangay Resolution No. 02-2014 and Appropriation Ordinance No. 02 Series of 2014).
