3. Real I – Five Hundred Sixty Seven Thousand Eight Hundred Twenty One Pesos and 08/100 (Php 567,821.08)(Please see attached Barangay Resolution No.03-2014 Series of 2014 and Appropriation Ordinance No. 02-2014 Series of 2014).

WHEREFORE, after thorough deliberation on the aforementioned barangay budgets, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangays P.F. Espiritu III, San Nicolas II, Real I and San Nicolas III provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
