AN ORDINANCE REQUIRING ALL THE BARANGAYS OF THE CITY OF BACOOR TO ESTABLISH THEIR OWN BARANGAY DISASTER RISK REDUCTION AND MANAGEMENT OFFICE.

**BE IT ORDAINED** by the Sangguniang Panlungsod in regular session duly assembled that:

Section 1. Republic Act No. 10121 (also known as the Philippine Disaster Risk Reduction and Management Act of 2010) mandates local government units like cities, municipalities, provinces, and barangays to establish their own Local Disaster Risk Reduction and Management Offices (LDRRMO) in order to mitigate the effects of natural and man-made calamities. Pursuant thereto, all of the barangays of the City of Bacoor are hereby directed to establish their own Barangay Disaster Risk Reduction and Management Office in compliance with the pertinent provisions of RA 10121 and Joint Memorandum Circular No. 2014-1.


Section 2. This Ordinance shall take effect immediately upon posting on all the bulletin boards of all the barangays within the City of Bacoor and after being published once in a newspaper of general circulation in the Province of Cavite.

Section 3. All ordinances, resolutions, executive orders, and memoranda contrary to, or in conflict with, the foregoing provisions are hereby expressly repealed and/or modified.
