AN ORDINANCE CREATING VARIOUS POSITIONS IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD, CITY GOVERNMENT OF BACOOR, PROVINCE OF CAVITE.

WHEREAS, Section 76 of Republic Act No. 7160 empowers local government units to design and implement its own organizational structure and staffing pattern.

WHEREAS, there is a need to create additional various positions in the Office of the Sangguniang Panlungsod due to the exigencies of public service pursuant to the ratification of Republic Act No. 10160 dated June 23, 2012 and the need to upgrade the Sangguniang Information System (SIS) in cooperation with the Department of Interior and Local Government (DILG) pursuant to the project of the Sangguniang Panlungsod and the Office of the City Vice Mayor known as the "Bacoor Sanggunian Information System Technical Enhancement and Reprogramming" (Bacoor-SISTER) project.

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED by the Sangguniang Panlungsod of Bacoor, Province of Cavite, in regular session

assembled, to create various positions under the Office of the Sangguniang Panlungsod, to wit:

No. of Positions	Position Title (Salary Grade)	Position Status
1	Computer Programmer II (SG 15)	Permanent
1	Computer Operator IV (SG 14)	Permanent

The said additional positions will be responsible for the technical enhancement, reprogramming, and maintenance of the SIS, the Bacoor City Council website (www.bacoorcouncil.gov.ph), and the "paperless deliberations" project of the Sangguniang Panlungsod. The appointment of any person to the said positions is subject to the provisions of pertinent civil service laws and regulations.

ORDAINED MOREOVER, that the Sangguniang Panlungsod shall appropriate the necessary funds in Supplemental Budget No. 3 for Calendar Year 2014 of the City Government of Bacoor to cover the salaries and other benefits of the employees who will be appointed to the positions above-mentioned.

ORDAINED FURTHER, that this Ordinance shall take effect upon its posting in at least two (2) conspicuous places within the City of Bacoor and publication in a newspaper of general circulation within the City of Bacoor.

ORDAINED FINALLY, that the Civil Service Commission, City Budget Office, Office of the City Mayor and the Human Resources Development and Management Department (HRDMD) shall be furnished copies of this Ordinance.








