
Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Annual General Fund Budget of barangay Bayanan in the amount of Four Million Six Hundred Nine Thousand Four Hundred Sixty Six Pesos (Php 4,609,466.00). Attached is the Barangay Resolution No. 01-14 and Barangay Appropriation Ordinance No. 01-14 dated January 24, 2014.

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on regular session assembled, HEREBY ORDAINED AS IT IS HEREBY ORDAINED, to approve the Annual General Fund Budget of Barangay Bayanan provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
