- Niog I Six Hundred Thirty Thousand Five Hundred Thirty Pesos and 36/100 (Php 630,530.36) (Please see attached Barangay Resolution No. 02-2014 Series of 2014 and Appropriation Ordinance No. 02-2014 Series of 2014 dated November 11, 2014); and
- Mabolo I One Hundred Seventy One Thousand Three Hundred Four Pesos and 78/100 (Php 171,304.78) (Please see attached Barangay Resolution No. 02-2014 Series of 2014 and Appropriation Ordinance No. 02-2014 Series of 2014 dated November 28, 2014)
