AN ORDINANCE APPROVING THE ANNUAL GENERAL FUND BUDGET OF BARANGAY SAN NICOLAS III IN THE CITY OF BACOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Annual General Fund Budget of Barangay San Nicolas III, in the amount of Fourteen Million Seven Hundred Ten Thousand Seven Hundred Ninety Pesos (Php 14,710,790.00).

WHEREAS, the City Budget Officer, Mrs. Elvinia Guerrero, reported to the Sangguniang Panlungsod that the item for disbursement of appropriation in the proposed budget of Barangay San Nicolas III for Ugnayan ng Barangay at Simbahan (UBAS) amounting to One Hundred Forty Thousand One Hundred Seven and 60/100 (PhP 140,107.60) should be held in abeyance pending submission by the said barangay of the legal basis for the funding of the said program pursuant to Section 335 of Republic Act 7160 of the Local Government Code of 1991 which states that "no public money or property shall be appropriated or applied for religious or private purposes".

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Annual General Fund Budget of Barangay San Nicolas III in the amount of Fourteen Million Seven Hundred Ten Thousand Seven Hundred Ninety Pesos (Php 14,710,790.00) provided that the above-mentioned barangay complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED MOREOVER, the item for disbursement of appropriation in the proposed budget of Barangay San Nicolas III for Ugnayan ng Barangay at Simbahan (UBAS) amounting to One Hundred Forty Thousand One Hundred Seven and 60/100 (PhP 140,107.60) shall be held in abeyance pending submission by the said barangay of the legal basis for the funding of the said program pursuant to Section 335 of Republic Act 7160 of the Local Government Code of 1991 which states that "no public money or property shall be appropriated or applied for religious or private purposes".
