6. Mambog I – Six Million Three Hundred Twenty Nine Thousand Nine Hundred Eight Pesos (Php 6,329,908.00) (Please see attached Barangay Resolution No. 02-15 and Appropriation Ordinance No. 01-2015 dated January 2, 2015).

WHEREFORE, after thorough deliberation on the aforementioned barangay budgets, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Annual General Fund Budget of the following Barangays Dulong Bayan, Sinaguelasan, Aniban III, Zapote V, Habay I and Mambog I provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
