
WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Annual General Fund Budget of Barangays to wit:

- Panapaan I Three Million Two Hundred Twenty One Thousand Two Hundred Sixty Five Pesos (Php3,221,265.00) (Please see attached Barangay Resolution No. 01-2015 and Appropriation Ordinance No. 01-2015 dated January 10, 2015);
- Molino IV Twenty Million Three Hundred Sixty Two Thousand Five Hundred Ninety Pesos (Php20,362,590.00) (Please see attached Barangay Resolution No. 01-15 and Appropriation Ordinance No. 01-2015 dated January 4, 2015);
- 3. Mambog V Three Million Two Hundred Twelve Thousand Five Hundred Eighty Seven Pesos (Php3,212,587.00) (Please see attached Barangay Resolution No. 01-15 and Appropriation Ordinance No. 01-2015 dated January 2, 2015);

WHEREAS, the City Budget Officer, Mrs. Elvinia Guerrero, reported to the Sangguniang Panlungsod that the item for disbursement of appropriation in the proposed budget of the above mentioned various Barangays for Ugnayan ng Barangay at Simbahan (UBAS) should be held in abeyance pending submission by the said barangays of the legal basis for the funding of the said program pursuant to Section 335 of Republic Act 7160 of the Local Government Code of 1991 which states that "no public money or property shall be appropriated or applied for religious or private purposes".
