**WHEREFORE**, after thorough deliberation on the aforementioned barangay budgets, the Sangguniang Panlungsod on its 88<sup>th</sup> regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Mambog III, Talaba VI, Niog III, Tabing Dagat, Salinas I & II and Molino V provided that the above-mentioned budgets complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
