CITY ORDINANCE NO. CO 45-2015 Series of 2015

AN ORDINANCE CREATING THE CITY OF BACOOR NATIONAL HIGH SCHOOL SITUATED AT GREEN VALLEY, BARANGAY SAN NICOLAS III, CITY OF BACOOR, CAVITE AND AUTHORIZING THE RELEASE OF PUBLIC FUNDS FOR THE CONSTRUCTION THEREOF.

WHEREAS, Article XIV, Section 2 (2) of the 1987 Constitution mandates that the State shall "establish and maintain a system of free public education in the elementary and high school levels. Without limiting the natural right of parents to rear their children, elementary education is compulsory for all children of school age".

**WHEREAS**, there is a need for the construction of additional public high schools to provide for the education of the youth residing within the City of Bacoor.

**WHEREAS**, one of the areas where such a public high school should be constructed is at Barangay San Nicolas III.

**WHEREAS**, the construction of the said school will make education more accessible to people residing within or near Barangay San Nicolas III.

**NOW THEREFORE**, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by the members of the City Council duly assembled, **BE IT ORDAINED** by the Sangguniang Panlungsod that:


Section 1. A public high school to be known as the CITY OF BACOOR NATIONAL HIGH SCHOOL is hereby created.

Section 2. The said public high school shall be constructed within Green Valley Subdivision, Barangay San Nicolas III, City of Bacoor, Cavite.

Section 3. The available funds of the City of Bacoor shall be utilized in the construction of the said school, subject to pertinent laws and government regulations.

Section 4. This Ordinance shall take effect immediately after a copy of this Ordinance has been published once in a newspaper of general circulation within the City of Bacoor.

Section 5. Let various government agencies concerned be furnished with copies of this Ordinance.
