AN ORDINANCE CONCURRING IN THE EXTENSION OF THE APPOINTMENT OF ATTY. KHALID A. ATEGA, JR. AS ACTING CITY ADMINISTRATOR IN A CONCURRENT AND TEMPORARY CAPACITY.

WHEREAS, in a Memorandum Order No. 392, Series of 2015, dated 26 October 2015, the City Mayor extended the appointment of Atty. Khalid A. Atega, Jr. as Acting City Administrator on the condition that the said appointment shall be concurrent and temporary in nature with no additional salaries or benefits.

WHEREAS, on 26 October 2015, the Honorable Mayor referred the said appointment to the Sangguniang Panlungsod for its concurrence and approval.

WHEREAS, Atty. Atega took no part in the deliberations of the council with regard the said matter.

NOW THEREFORE, upon joint motion of all the members of the Sangguniang Panlungsod of Bacoor, Cavite in regular session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED THAT:**

Section 1. The Sangguniang Panlungsod concurs in the extension of the appointment of Atty. Khalid A. Atega, Jr. as Acting City Administrator of the City of Bacoor, Cavite subject to the following conditions:

1. The said extension of appointment shall only be from 26 October 2015 up to 15 November 2015;
2. Atty. Atega is hereby directed to concurrently exercise all the powers and responsibilities in his capacity as Secretary to the Sangguniang Panlungsod; and
3. Atty. Atega is hereby authorized and directed to exercise all the powers and responsibilities as head of the City Administrator's Office. However, he shall not be entitled to any additional salaries and benefits aside from the salaries and benefits he is currently receiving as Secretary to the Sangguniang Panlungsod.
