

 Zapote I – One Hundred Fifty Thousand Two Hundred Thirty Three Pesos and 14/100 (Php150,233.14) (Please see attached Barangay Resolution No. 03-2015 Series of 2015 and Appropriation Ordinance No. 03-2015 Series of 2015 dated November 14, 2015);

WHEREFORE, after thorough deliberation on the aforementioned barangay budgets, the Sangguniang Panlungsod on its 99th regular session assembled, HEREBY ORDAINED AS IT IS HEREBY ORDAINED, to approve the Supplemental Appropriation of Barangay Ligas III, Mambog I, P.F. Espiritu I, Kaingin, Aniban IV, Mambog V and Zapote I provided that the above-mentioned budgets complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
