CITY ORDINANCE NO. CO 57A-2015 SERIES OF 2015

AN ORDINANCE PROHIBITING TWO OR MORE MALE MOTORYCLE PASSENGERS FROM RIDING TANDEM WITHIN THE CITY OF BACOOR AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.

BE IT ORDAINED by the Sangguniang Panlungsod of the City of Bacoor, Cavite THAT:

Section 1. Short Title. This Ordinance shall also be known and referred to as the "Anti 'Riding-In-Tandem' Ordinance of the City of Bacoor".

Section 2. Prohibited Act. The use or operation of motorcycles regardless of engine displacement by two or more male passengers riding tandem everyday from 7:00 am up to 10:00 pm within the City of Bacoor is hereby prohibited.

Section 3. Public Information Campaign. The Public Information Office of the City of Bacoor is hereby mandated to distribute flyers and to prominently display posters in various public places within the City of Bacoor announcing the enactment of this Ordinance, the penalties imposed hereunder, and the act prohibited under Section 2 hereof. The said public information campaign shall begin ten (10) days after the publication of this Ordinance in a newspaper of general circulation within the City of Bacoor.

Section 4. Penalties. Persons who shall violate this Ordinance shall be penalized as follows:

First Offense:

Payment of fine of Three Thousand Pesos (PhP3,000.00) by the driver of the motorcycle at the time of apprehension.

Second Offense:

Payment of fine of Four Thousand Pesos (PhP4,000.00) by the driver of the motorcycle at the time of apprehension.

Section 6. Repeal. All ordinances, resolutions, and executive orders in conflict with this Ordinance are hereby repealed or modified.
