AN ORDINANCE RENAMING, CONVERTING, ESTABLISHING AND SEPARATING VARIOUS PUBLIC SCHOOLS IN THE CITY OF BACOR, CAVITE.

WHEREAS, Article 21 of Rule IV of the Rules and Regulations Implementing the Local Government Code of 1991 (also known as Republic Act No. 7160) empowers the *Sangguniang Panlungsod* of component cities such as the City of Bacoor to rename, among others, city public elementary, secondary, and vocational or technical schools in consultation with the former National Historical Institute (NHI) now known as the National Historical Commission of the Philippines (NHCP).

WHEREAS, Department of Education Order No. 40 was promulgated on 26 August 2014 by DepEd Secretary Armin A. Luistro to be known as the "Revised Guidelines for Establishment, Merging, Conversion, and Naming/Renaming of Public Schools, and Separation of Public School Annexes in Basic Education".

WHEREAS, most of the public elementary and secondary schools in the City of Bacoor either have confusingly similar names, were named after things or places that have no historic significance to the City of Bacoor and/or its residents, or no longer symbolize the true nature of the schools concerned.

WHEREAS, there is a need to reconstitute several public elementary and secondary schools in the City of Bacoor by either establishing, separating, or converting them to better address the educational needs of the youth pursuant to the implementation of the K-12 program of the national government.

NOW THEREFORE, upon motion of Councilor Rowena Bautista-Mendiola unanimously approved by all the councillors present, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod in regular session assembled that:

Section 1. Title.—This Ordinance shall also be known as the "**Bacoor Public School Reconstitution Ordinance**".

Section 2. Separation from Bacoor National High School-Main of the Bacoor National High School-Tabing Dagat Annex and the Bacoor National High School-Gawaran Annex and Renaming the said high schools. The Bacoor National High School-Tabing Dagat Annex and the Bacoor National High School-Gawaran Annex are hereby separated from the main campus of the Bacoor National High School. In order to avoid public confusion, the following schools are hereby renamed as follows:

Existing Name	New Name
Bacoor National High School-Tabing Dagat Annex	Padre Mariano Gomez National High School
National High School Villa Maria Annex	City of Bacoor Science High School
Bacoor National High School-Gawaran Annex	City of Bacoor National High School-Gawaran (Annex)

Section 4. Conversion of the Queensrow Elementary School and the Eastern Bacoor National High School. – The Queensrow Elementary School and the Eastern Bacoor National High School are hereby converted into an integrated school pursuant to DepEd Order No. 40-S-2014 and shall henceforth be known as the **City of Bacoor Integrated School-Queensrow**.

Section 5. Establishment of New Secondary Schools. Pursuant to the policy of the city government to provide universal quality education to the people of the City of Bacoor, the following new public high schools are hereby established:

- a. **City of Bacoor National High School-Georgetown;**
- b. **City of Bacoor National High School-Salinas;**
- c. **City of Bacoor National High School-San Nicolas;**
- d. **City of Bacoor National High School-Molino V;**
- e. **City of Bacoor National High School-Springville;**
- f. **City of Bacoor National High School-Panapaan;**
- g. **Gen. Edilberto Evangelista National High School;**
- h. **City of Bacoor National High School-San Nicolas II; and**
- i. **City of Bacoor Senior High School-San Nicolas III.**

Section 6. Establishment and Renaming of New Elementary Schools. The Malipay Elementary School located at Malipay, Molino IV, Bacoor City, Cavite is hereby established and shall hereafter be renamed as the **Responsible Village Leaders Academy Elementary School**. A public elementary school located at Progressive Village, Molino II, Bacoor City, Cavite is hereby established and shall hereafter be named as the **Progressive Elementary School**.

Section 7. Separability Clause. – If, for any reason or reasons, any part of the provisions of this Ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected thereby shall continue to be in full force and effect.

Section 8. Repealing Clause. – All Ordinances, resolutions, Circulars, Memorandums or Rules and regulations inconsistent with the provision of this Ordinance are hereby repealed and modified accordingly.

Section 9. Effectivity Clause. – This Ordinance shall take effect immediately upon its posting in at least three (3) conspicuous places within the City of Bacoor after it has been published once in a newspaper of general circulation in the Province of Cavite, and after it has been approved by the National Historical Commission of the Philippines (NHCP).

Section 10. Dissemination. Let copies of this Ordinance be furnished to the Office of Rep. Lani Mercado-Revilla, to the NHCP, to the DepEd, and to other government offices concerned.
