AN ORDINANCE CREATING VARIOUS POSITIONS UNDER THE OFFICE OF THE CITY MAYOR AND THE CITY BUDGET OFFICE OF THE CITY OF BACOOR.

WHEREAS, the Bacoor Government Center (BGC) complex is now fully operational and is now being used by thousands of city government employees and taxpayers everyday.

WHEREAS, Section 11, paragraph 1 (viii) of Republic Act No. 10160 (also known as the "Charter of the City of Bacoor") empowered the Sangguniang Panlungsod to "determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government".

WHEREAS, there is a need to create various positions under the Office of the City Mayor and the City Budget Office to further improve the delivery of various public services.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Bacoor, Cavite THAT:


Section 4. Separability. -- Any provision of this Ordinance declared void by any court of law shall not affect the other provisions hereof not affected by such declaration.
