AN ORDINANCE APPROVING THE ANNUAL GENERAL FUND BUDGET OF VARIOUS BARANGAYS IN THE CITY OF BACOOR.

- Dulong Bayan Four Million Nine Hundred One Thousand Four Hundred Thirty Two Pesos (Php 4,901,432.00) (Please see attached Barangay Resolution No. 01-16 and Barangay General Appropriation Ordinance No. 01-2016 dated February 17, 2016);
- Molino IV Twenty Two Million Three Hundred Forty Five Thousand Three Hundred Thirty Six Pesos (Php 22,345,336.00) (Please see attached Barangay Resolution No. 01-16 January 2, 2016 and Barangay General Appropriation Ordinance No. 01-16 dated May 5, 2016);
