ORDAINED AS IT IS HEREBY ORDAINED by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the re-alignment of funds under the budget of the Office of the Sangguniang Panlungsod for the "Other Maintenance and Operating Expenses" to "Gasoline, Oil and Lubricants Expenses" as indicated above covered by Annual Budget for CY 2016.

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that :

Section 1. The purpose of this Ordinance is to appropriate the amount of Two Million Pesos (PhP2,000,000.00) for the "Gasoline, Oil and Lubricants Expenses" under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2016;

Section 2. The above-mentioned amount of Two Million Pesos (PhP2,000,000.00) shall be re-aligned from the "Other Maintenance and Operating Expenses" under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2016;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. —This Appropriation Ordinance shall take effect upon its approval.
