AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY
BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACOOR.

WHEREAS, Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

3. Mabolo III – Two Hundred Thirty Three Thousand Six Hundred Thirty One Pesos and 05/100 (Php 233,631.05) (Please see attached Barangay Resolution No. 02-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 02-2016 Series of 2016 dated July 8, 2016);
4. Aniban III – Three Hundred Forty Five Thousand One Hundred Ninety Three Pesos and 22/100 (Php 345,193.22) (Please see attached Barangay Resolution No. 01-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 01-2016 Series of 2016 dated June 07, 2016);

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay San Nicolas III, Kaingin, Mabolo III and Aniban III, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.






