6. San Nicolas I – Six Hundred Eighty Six Thousand Six Hundred Eight Pesos and 61/100 (Php 686,608.61) (Please see attached Barangay Resolution No. 05-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 03-2016 Series of 2016 dated July 22, 2016);
7. Maliksi II – One Hundred Thirty Eight Thousand Six Hundred Sixty Four Pesos and 96/100 (Php 138,664.96) (Please see attached Barangay Resolution No. 02-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 02-2016 Series of 2016 dated July 11, 2016);
8. Panapaan V – Three Hundred Thirteen Thousand Four Hundred Four Pesos and 61/100 (Php 313,404.61) (Please see attached Barangay Resolution No. 02-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 02-2016 Series of 2016 dated July 08, 2016);
9. Queens Row East – Six Hundred Eleven Thousand Three Hundred Thirty Eight Pesos and 90/100 (Php 611,338.90) (Please see attached Barangay Resolution No. -2016 Series of 2016 and Barangay General Appropriation Ordinance No. -2016 Series of 2016 dated 2016);

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Maliksi III, Talaba I, Molino VI, Real II, Molino I, San Nicolas I, Maliksi II, Panapaan V & Queens Row East, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive and others concerned for their information and guidance.






