7. Zapote IV – Four Hundred Thirty Three Thousand Pesos (Php 433,000.00) (Please see attached Barangay Resolution No. 02-12016 Series of 2016 and Barangay General Appropriation Ordinance No. 02-2016 Series of 2016 dated May 28,2019);

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Zapote I, Panapaan II, Sineguelasan, Banalo, Panapaan III, Salinas IV and Zapote IV, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
