WHEREAS, Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, HEREBY ORDAINED AS IT IS HEREBY ORDAINED, to approve the Supplemental Appropriation of Barangays Zapote II & Mambog IV, provided that the abovementioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
