AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACOR.

WHEREAS, Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

1. Zapote II – Two Hundred Seventy One Thousand Two Hundred Forty Nine Pesos and 59/100 (Php 271,249.59) (Please see attached Barangay Resolution No. 02-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 02 Series of 2016 dated September 8, 2016);
2. Mambog IV – Three Million One Hundred Fifty Thousand Fifty Nine Pesos and 41/100 (Php 3,150,059.41) (Please see attached Barangay Resolution No. 01-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 01-2016 Series of 2016 dated August 8, 2016);

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangays Zapote II & Mambog IV, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

**ORDAINED FURTHER**, to furnish copies of this ordinance to the Office of the Local Chief Executive and others concerned for their information and guidance.

**ORDAINED LASTLY**, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.






