CITY ORDINANCE NO. CO 48-2016

AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY BUDGET OF DAAN BUKID AMOUNTING TO THREE HUNDRED FIVE THOUSAND EIGHT HUNDRED EIGHTY TWO PESOS AND 62/100 (Php305,882.62).

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of barangay Daan Bukid in the amount of Three Hundred Five Thousand Eight Hundred Eighty Two Pesos and 62/100 (Php 305,882.62). Attached is the Barangay Resolution No. 02 Series of 2016 and Appropriation Ordinance No. 02-2016 Series of 2016 dated August 2, 2016.
