AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY BUDGET OF ANIBAN V AMOUNTING TO TWO HUNDRED TEN THOUSAND FIVE HUNDRED THIRTY SIX PESOS AND 06/100 (Php210,536.06).

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of barangay Aniban V in the amount of Two Hundred Ten Thousand Five Hundred Thirty Six Pesos and 06/100 (Php 210,536.06). Attached is the Barangay Resolution No. 02 Series of 2015 and Appropriation Ordinance No. 02-2015 Series of 2015 dated December 2, 2015.
