Presented for approval before the members of the Bids and Awards Committee the above titled resolution, pursuant to Sec. 35 of the 2016 Revised IRR of R.A. No. 9184:

WHEREAS, on 29 November 2018, the "Purchase of Transportation Equipment Manlift/Sky Crane (Motor Vehicle) (ABC=PhP4,852,000), APP No. 1958A-4-001, was first posted/advertised with PhilGEPS Reference No. 5863111;

WHEREAS, on 20 December 2018, R2A Construction and Trading as the lone bidder submitted bid envelopes which was declared ineligible due to the absence of the Statement of Single Largest Completed Contract (SLCC);

WHEREAS, the mandatory review of the terms, conditions, specifications, including the Approved Budget for the Contract revealed that the failure of bidding is solely attributable to the ineligibility of the supplier/contractor;

WHEREAS, on 27 December 2018, the BAC issued Resolution No. 2018-45 Declaring Failure of Bidding for the "Purchase of Transportation Equipment Manlift/Sky Crane" (Motor Vehicle);

WHEREAS, on 31 January 2018, the "Purchase of Transportation Equipment Manlift/Sky Crane (Motor Vehicle) (ABC=PhP4,852,000), APP No. 1958A-4-001, was again posted/advertised with PhilGEPS Reference No. 5989996;

WHEREAS, on 21 February 2019, the scheduled deadline for submission and receipt of bids lapsed but no bidder submitted bid envelopes;

WHEREAS, Section 35.1(a) provides that "The BAC shall declare the bidding a failure when... [n] o bids are received"; when the bidding a failure of the

WHEREAS, the mandatory review of the terms, conditions, specifications, including the Approved Budget for the Contract revealed that the failure of bidding found no other factors attributable to the failure of bidding for the second time of this particular project;

WHEREAS, there is already substantial delay in the delivery of the required equipment for immediate utilization;

- (a) DECLARE a failure of bidding in the "Purchase of Transportation Equipment Manlift/Sky Crane (Motor Vehicle)" (ABC=PhP4,852,000), APP No. 1958A-4-001 for the second time;
- (b) RECOMMEND to the City Mayor the change of the method of procurement from Public Bidding to Negotiated Procurement under Sec.53.1 of the 2016 Revised IRR of RA No. 9184;
- (c) In case of approval, ADOPT the foregoing changes in the Annual Procurement Plan, particularly on the "Purchase of Transportation Equipment Manlift/Sky Crane (Motor Vehicle)" (ABC=PhP4,852,000), APP No. 1958A-4-001;
