In the Pre-Bidding Conference held last January 24, 2013 at Mayor's Office Conference Hall, the BAC answered the queries of participating bidders and shall be binding as an amendment to inconsistent or objected provisions of the Bidding Documents accordingly:

Rilem Pharma: Inquiry on the Delivery Period Requirement (based on the posting at PhilGEPS) the delivery stated was April 15-June 15, 2013)?

BAC:

It might have been some error in encoding. Normally, delivery should be within 30-days delivery period upon receipt of NTP. It should tentatively be March 1-30, 2013.

**Dynasty Pharmaceuticals:** Can an Official Receipt as proof of payment for Mayor's Permit be a substitute for Mayor's Permit as an eligibility requirement? Issuance of the permit will take some time prior to release.

BAC:

No. Eligibility requirements are exclusive and absolute. It is required for prospective bidders to submit the 2013 Mayor's Permit.

**Rilem Pharma:** Same question because the Official Receipt is issued immediately after the payment of taxes but the Mayor's Permit will took about 2 weeks.

You can have ample time to secure the Mayor's Permit because the deadline will still be on Feb.14. Enough time ahead for the release of your permit.

**Rilem Pharma:** Is it acceptable to submit the audited financial statement last April 2012 because the filing of 2012 will still be on April 15, 2013 while our NFCC will still based on last year.

**BAC:** It is acceptable to submit because it is not yet due for April 15 filing this year. However, with regards to NFCC, only assets and liabilities may not be affected. The amount of ongoing projects will still have to be updated.

. Dynasty Pharmaceuticals: How many copies are required to submit in the bidding?

BAC: As indicated in the Bid Data Sheet: One (1) original and Two (2) copies.

Rilem Pharma: What form will be used for goods offered within the Philippines?

**BAC:** If goods were manufactured locally, use the appropriate form in the Bidding Documents. If goods offered are from abroad, use the other form. The form must be accomplished completely to establish equal footing of proposals. This is important in case there will be discrepancies.

Dynasty Pharmaceuticals: What exact amount of security bond?

BAC:

The Bid Data Sheet (BDS) provides the values for bid security depending on the form: Surety – 5% of ABC and Cash – 2% of ABC

POSTING AREA:

Rilem Pharma: If Surety Bond is used, do we still need to accomplish a Bid Securing Declaration?

**BAC:** No. The two are distinct forms of bid security. You choose only one depending on your option. Bid Securing Declaration (BSA) was recently introduced as another form of bid security. However, BSA requires stricter compliance and heavier penalties for non-compliance in the process.
