

**A RESOLUTION RECOMMENDING THE APPROVAL OF  
THE FIRST SUPPLEMENTAL PROCUREMENT PLAN  
(SUPPLEMENTAL APP NO. (S) 2014-01 (LSB) BUDGET FOR 2014)**

Presented for approval before the members of the Bids and Awards Committee the RECOMMENDATION FOR APPROVAL OF THE FIRST SUPPLEMENTAL PROCUREMENT PLAN (SUPPLEMENTAL APP NO. (S) 2014-01 (LSB) FOR THE 2014 BUDGET, to wit:

*WHEREAS, in its Resolution No. 01- S-2014 the Local School Board passed and approved its Supplementary Budget No. covering the current Operating Expenditures and Capital Outlay to be incurred by the City School, which require additional funding for the current year;*

*WHEREAS, it is stipulated in Section 7.1 of the Revised IRR of Republic Act No. 9184 that "All procurement shall be within the approved budget of the procuring entity and should be meticulously and judiciously planned by the procuring entity. x x x;"*

*WHEREAS, it is stipulated in Section 7.2. of the Revised IRR of Republic Act No. 9184 that "(E)ach procuring entity shall judiciously prepare, maintain and update an APP for all its procurement, that shall include, for each individual project, a Project Procurement Management Plan (PPMP). The APP shall bear the approval of the head of the procuring entity or second-ranking official designated by the head of the procuring entity to act on his behalf, and must be consistent with its duly approved yearly budget and x x x that "(N)o procurement shall be undertaken unless it is in accordance with the approved APP of the procuring entity.*


*WHEREAS, this FIRST Supplemental APP also contained the items that were submitted by the end-users for proper procurement process indicated as Supplemental APP No. (S) 2014-01 which is attached hereto and made as an integral part hereof;*

*WHEREFORE, after careful deliberations and study of the matter, the Bids and Awards Committee resolved to recommend the approval of the FIRST SUPPLEMENTAL PROCUREMENT PLAN (APP (S) 2014-1) FOR THE BUDGET 2014;*

**RESOLVED FINALLY**, to furnish the Hon. City Mayor, STRIKE B. REVILLA, with a copy of this Resolution for his information reference.
