**A RESOLUTION RECOMMENDING THE APPROVAL OF THE  
SECOND AMENDATORY PROCUREMENT PLAN  
(AMENDATORY APP NO. (A) 2014-02 BUDGET FOR 2014)**

Presented for approval before the members of the Bids and Awards Committee the RECOMMENDATION FOR APPROVAL OF THE FIRST AMENDATORY PROCUREMENT PLAN (AMENDATORY APP NO. (A) 2014-02 FOR THE BUDGET 2014, to wit:

*WHEREAS, it is stipulated in Section 7.1 of the Revised IRR of Republic Act No. 9184 that "All procurement shall be within the approved budget of the procuring entity and should be meticulously and judiciously planned by the procuring entity. x x x;"*

*WHEREAS, it is stipulated in Section 7.3.5 of the subject IRR that "(A)s soon as the x x x appropriation ordinance, x x x becomes final, the end-user units shall revise and adjust the PPMP to reflect the budgetary allocation for their respective PAPs. The revised PPMPs shall be submitted to the BAC, through its Secretariat, for the finalization of the modes of procurement under the proposed APP. The APP shall then be approved in accordance with Section 7.2 of this IRR;"*

*WHEREAS, it is stipulated in Section 7.2 of the subject IRR that "(N)o procurement shall be undertaken unless it is in accordance with the approved APP of the procuring entity. The APP shall bear the approval of the Head of the Procuring Entity or second-ranking official designated by the Head of the Procuring Entity to act on his behalf, and must be consistent with its duly approved yearly budget;"*

*WHEREAS, it is likewise stipulated in Section 7.4 of subject IRR that "(U)pdating of the individual PPMPs and the consolidated APP for each procuring entity shall be undertaken every six (6) months or as often as may be required by the Head of the Procuring Entity. The updating of the PPMPs shall be the responsibility of the respective end-user units of the Procuring Entities, while the consolidation of these PPMPs into an APP shall be lodged with the BAC Secretariat, subject to approval of the Head of the Procuring Entity."*


WHEREAS, this FIRST Amendatory APP also contained the items for amendment that were submitted by the end-users for proper procurement process indicated as Amendatory APP No. (A)2014-02 which is attached hereto and made as an integral part hereof;

WHEREFORE, after careful deliberations and study of the matter, the Bids and Awards Committee resolved to recommend the approval of the FIRST AMENDATORY PROCUREMENT PLAN (APP (A) 2014-02) FOR THE BUDGET 2014;

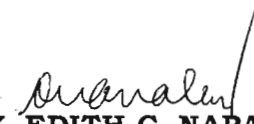

*WHEREAS, the procurement of utility services (water, electricity, telecommunications and internet services providers) shall be part of Annex "A" hereof of the APP and shall be recommended in accordance with GPPB resolution 019-2006 dated 06 December 2006;*

*WHEREAS, the detailed plans and programs of Bacoar Disaster Risk Reduction and Management Office utilizing the 5% Calamity fund shall form party of Annex "B" hereof;*

*WHEREAS, Annex "C" hereof shall contain lump sum procurement programs for infrastructure projects under 20% Development Plan and were broken down into individual project components and their respective locations as defined in the Annual Investment Plan approved by the Sangguniang Panlungsod;*

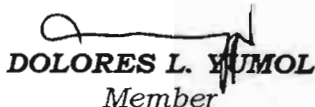
