A RESOLUTION RECOMMENDING THE APPROVAL OF THE ANNUAL PROCUREMENT PLAN (APP) FOR THE FISCAL YEAR 2018 IN COMPLIANCE WITH RULE II SEC. 7 OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF R.A. 9184

Presented for approval before the members of the Bids and Awards Committee the recommendation for Approval of the Annual Procurement Plan (APP) for the Fiscal Year 2018 in compliance with Rule II Sec. 7 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184, to wit:

WHEREAS, Section 7.1 of the IRR stipulates that all procurement should be within the approved budget of the procuring entity and should be meticulously and judiciously planned by the procuring entity concerned. No government procurement shall be undertaken unless it is in accordance with an approved Annual Procurement Plan (Sec. 7.2);

WHEREAS, the Annual Procurement Plan (APP) was consistent with the Annual Budget for 2018 under Appropriation Ordinance No. CO-57-2017 Series of 2017 which was approved on November 20, 2017 including lump sum provisions for foreseeable contingencies and expected maintenance and other operating expenses whose mode of procurements which shall initially be under competitive bidding;

WHEREAS, this (original) APP conforms with the prescribed format recommended by the Government Procurement Policy Board (GPPB) which includes among others the APP Code, Procurement Program/Project, PMO/End User, Mode of Procurement, Schedule of Procurement Activity, Source of Fund, Approved Budget for the Contract(ABC) and the Brief Description of the Project;

WHEREAS, offices and agencies without PPMP's including those who submitted incomplete and acceptable PPMP consistent with the Annual Budget 2018 has been received by the BAC thru the Secretariat;

WHEREAS, any changes as to the amount, component and use of the appropriations not defined in the Annual Budget and the Annual Procurement Plan shall seek amendatory APP from the BAC, prior approval from Sanggunian if necessary, and approved by the City Mayor as the Head of the Procuring Entity;

WHEREAS, the procurement of utility services (water, electricity, telecommunications and internet services providers) shall be part of the APP and shall be recommended in accordance with GPPB Resolution 019-2006 dated December 6, 2006;

WHEREAS, the detailed plans and programs of Bacoor Disaster Risk Reduction and Management Office utilizing the 5% Disaster Risk Reduction and Management Fund shall form part of Annex "A" hereof;

WHEREAS, Annex "B" hereof shall contain lump sum procurement programs for infrastructure projects under the 20% Development Plan and were broken down into individual projects components and their respective locations as defined in the Annual Investment Program approved by the Sangguniang Panlungsod;

WHEREAS, Local School Board shall form part as Annex "C" hereof which contains various programs necessary for the implementation of projects and activities for different schools in the city as embodied in the Local School Board Resolution No. 05-2017 and Ordinance No. 05, both series of 2017;

WHEREFORE, after careful deliberations and study of the matter, the Bids and Awards Committee resolved to recommend the approval of the ANNUAL PROCUREMENT PLAN (APP) FOR THE FISCAL YEAR 2018 IN COMPLIANCE WITH RULE II SEC. 7 OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF R.A. 9184;
