Procurement of Drugs and Medicines Supplies for 3rd and 4th Quarter City Health Office

The BAC members were unable to constitute quorum on 03 September 2018 and 06 September 2018, and agreed on the following:

1. Due to the absence of quorum in the scheduled Pre-Bid Conference on 03 September 2018, the new scheduled Pre-Bid Conference is hereby moved to **10 September 2018, 1:00PM at the BAC Conference Room 2/F City Hall Building, Bacoor Government Center, Bayanan, Bacoor City, Cavite;**
2. As a consequence, the scheduled Deadline and Submission of Bids as well as the Opening of Bids shall be moved to **24 September 2018; deadline for submission and receipt of bids is 12:00PM and the opening of bids starts on 2:00PM**, of same date;
3. The Bidding Documents shall be amended as follows:
 - (a) Invitation to Bid – in Paragraph No. 2, “Delivery of the Goods is required in two batches, within 30 days for each batch, one in October 2018 and the other in November 2018.”;
 - (b) Invitation to Bid – in Paragraph No. 7, “Bids must be duly received by the BAC Secretariat at the address below on or before 24 September 2018, 12:00PM Philippine Standard Time. Xxx”

Bid opening shall be on 24 September 2018, 2:00PM Philippine Standard Time.”
 - (c) Bid Data Sheet – ITB Clause 1.1
The name of the Contract is “Procurement of Drugs and Medicines Supplies for 3rd and 4th Quarter – City Health Office”.
The identification number of the Contract is 1848-2-003.
 - (d) Bid Data Sheet – ITB Clause 13.1(c)

- 4. For Section VI – Schedule of Requirements (Attached with this bulletin as ANNEX “B”)**
 - Half of the quantities in the Purchase Request form shall constitute Batch 1 which shall be delivered in October 2018; Delivery period is 30 days;
 - The other half of the quantities shall constitute Batch 2 which shall be delivered on November 2018; Delivery period is 30 days;
- 5. For Section VII – Technical Specifications (Attached with this bulletin as ANNEX “C”)**
 - a. Sources of drugs and medicines as to the manufacturer and country of origin shall be disclosed;
 - b. In case of generic labeling of drugs and medicines must conform with DOH Administrative Order No. 2016-0008, dated March 21, 2016;
 - c. Expiry dates of drugs and medicines shall be at least one (1) year after delivery;
