- 2) Detailed estimates, including a summary sheet indicating the unit prices of construction materials, labor rates, and equipment rentals used in coming up with the Bid; and,
- 3) Cash flow by quarter or payment schedule.

Each bidder shall submit **ONE (1) Original and ONE (1) copies** of the first and second components of its bid.

Partial bid is not allowed. The infrastructure project is packaged in a single lot and the lot shall not be divided into sub-lots for the purposes of bidding, evaluation, and contract award.
