AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 4, SERIES OF 2012 INVOLVING AN AMOUNT OF FIFTY TWO MILLION FIVE HUNDRED THOUSAND PESOS (PHP 52,500,000,000.00) FOR CURRENT OPERATING EXPENDITURES AND CAPITAL OUTLAY OF THE CITY GOVERNMENT OF BACOOR FOR FISCAL YEAR 2012.

WHEREAS, Section 305 of Republic Act No. 7160 provides, *inter alia*, that "no money shall be paid out of the local treasury except in pursuance of an appropriations ordinance or law";

WHEREAS, the Office of the City Mayor formally requested the Sangguniang Panlungsod for the approval of an ordinance authorizing Supplemental Budget No. 4, Series of 2012, amounting to PhP 52,500,000.00;


WHEREAS, a series of committee hearings were held by the city council regarding the said supplemental budget during which, numerous resource persons were invited and extensive deliberations were made;

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica unanimously seconded by all the members of the Sangguniang Panlungsod then present, be it ordained in regular session assembled that:

Section 1. Supplemental Budget No. 4 of the City Government of Bacoor for Fiscal Year 2012 in the amount of Fifty Two Million Five Hundred Thousand Pesos (PhP52,500,000.00) for current operating expenditures and capital outlay is hereby approved gkakaisa sa Pagbabago...
