WHEREAS, there is a need to amend pertinent provisions of various municipal ordinances such as Municipal Ordinance No. 6-S-2008 pursuant to the ratification of Republic Act No. 10160 on June 23, 2012 converting Baccor into a component city of Cavite.

NOW, THEREFORE, during regular session assembled, upon motion of Councilor Venus D. De Castro duly seconded by Councilor Reynaldo D. Palabrica, BE IT ORDAINED AS IT IS HEREBY ORDAINED by the Sangguniang Panlungsod to amend various sections of this Ordinance to read as follows, to wit:

Section 1. The following provisions of Municipal Ordinance No. 6, Series of 2008 are hereby amended and shall henceforth read as follows:

"SECTION 1. Short Title---This ordinance shall also be known as the "INTEGRATED YOUTH AND SPORTS DEVELOPMENT ORDINANCE FOR THE CITY OF BACOOR AND CREATING THE OFFICE OF THE YOUTH AND SPORTS DEVELOPMENT COUNCIL".

SECTION 2. DECLARATION OF POLICY

- a. It is hereby declared the policy of the <u>city</u> Government of Bacoor to promote physical education and encourage sports programs, league competitions and amateur sports including training for international competition, to foster self discipline, teamwork and excellence for a healthy and alert citizenry;
- **b.** Subscribing to the International Charter of Physical Educational and Sports of UNESCO, the <u>City</u> Government believes that physical education and sports will contribute in inculcating fundamental human values underlying in the full development of a person.
- c. The <u>City</u> Government recognizes that sports development will effectively address the need for a comprehensive grassroots sports program centered on values formation inherent in the practice of sports and play (e.g. patriotism, nationalism, self discipline, respect for law and order, hard work, teamwork, camaraderie, sportsmanship and fair play), thus, preventing a child's chances of becoming a juvenile delinquent.

There is hereby created the BACOOR <u>CITY</u> SPORTS DEVELOPMENT COUNCIL ("BCSDC" for brevity) which shall act as the coordinator of all sports activities in the <u>City</u>. The <u>BCSDC</u> shall encourage the establishment of associations/organizations in every field of sports discipline as may be identified by the council. At the same time, the council shall formulate plans that will not only promote the sports, but the socio-economic, education, socio-cultural and civic programs of the <u>City</u> Government of the youth sector. The powers of the <u>BCSDC</u> shall be as follows:

A. Sports

- The <u>BCSDC</u> shall formulate guidelines, rules and regulations for all sports programs for the populace including both the youth and other interested citizens.
- 2. The <u>BCSDC</u> shall formulate a comprehensive sports and development program starting from the grassroots level to develop future career and national athletes.
- 3. The <u>BCSDC</u> shall organize a coaching pool, sports officials pool and athletes' pool for continuous training and development.
- The <u>BCSDC</u> shall assist in sports festivals, league competitions, "palaros" and other activities to have a year-round calendar of activities for the youth.
- 5. The <u>BCSDC</u> shall coordinate with the Department of Education and all schools and universities operating within the <u>City</u> to integrate their respective sports programs and direct the same to achieve the vision of developing career and national athletes.
- 6. The <u>BCSDC</u> shall establish a sports youth center to cater to the needs and development of the youth.
- 7. The <u>BCSDC</u> shall organize sports clinics, trainings and seminars by bringing certified sports facilitators for the youth.

B. Socio-Economic

- The <u>BCSDC</u> shall formulate guidelines, rules and regulations for a youth-hiring program throughout the year
- 2. The <u>BCSDC</u> shall assist the youth in finding jobs through TESDA and the PESO Office.
- 3. The <u>BCSDC</u> shall formulate guidelines, rules and regulations for assisting the youth in establishing micro-business by providing financial assistance, training, technical and marketing assistance.

E. Civic

- 1. The <u>BCSDC</u> shall formulate guidelines, rules and regulations in organizing a waste management program involving the youth to promote cleanliness in the **City**.
- The <u>BCSDC</u> shall forge Memorandum of Agreements to work with the schools on civic projects for their National Services Training Program (NSTP).
- The <u>BCSDC</u> shall coordinate with and assist the <u>City</u> General Services/Property Office (CGSO), DepEd and SK Federation on related programs and projects.

SECTION 5. **FUNDING FOR THE PROGRAM AND THE <u>BCSDC</u>**. Funding for this program and for the <u>BCSDC</u> shall come from the <u>City</u> 20% Development Fund and Sports Fund.

For this purpose the **City** Government may:

- Receive funding assistance from national agencies such as the Philippine Sports Commission (PSC) and private sectors such as private and multi-national corporations and business establishments operating in the <u>city</u> to address the need of high standard sports facilities, supplies and equipments; and
- Make representations and to receive donations, grants-in-aid and other forms of contributions whether in cash or in kind necessary for the advancement of sports development of the <u>City Government of</u> <u>Bacoor</u>.
- Include in the <u>city</u> development program the construction and provision of adequate and high standard sports facilities, supplies and equipment with the allocation of necessary funds for the same purpose; and
- 4. To improve the management, maintenance and operation of sport facilities owned and under the jurisdiction of the **city** Government.

SECTION 6. INFORMATION DISSEMINATION CAMPAIGN:

Sports development cannot be achieved without information- dissemination, documentation, research and marketing, hence, the **city** shall:

- Maximize the use and recognize the importance of media in promoting sports development in the locality;
- Develop a data bank, records section, and sports library which will help in the proper documentation, records management and in the conduct of research relative to sports.

 Market sports not only to augment financial resources but to promote and enhance recognition of athletes, coaches, trainors, including sports organizations from among the members of the community;

To further bolster and enhance sports development in the **City**, the **City** Government in coordination with local sports organizations including private individuals and sponsors shall promote sports through the launching of sports tournaments sponsored, fully or partly, by the **city** government for events where it has greater chances of winning in the regional, national and international competitions.

SECTION 7. **DOCUMENTATION**: The <u>BCSDC</u> through its Sports Coordinator shall maintain a system of the documentation of all sports competitions participated in by athletes from the City whether local, regional or national. The same office, in coordination with the Public Information Office, shall be tasked to document the achievement of the said athletes through photographs, videotapes and other media for future reference.

SECTION 8. **CASH INCENTIVES:** The <u>City</u> Government shall grant and provide the necessary support either monetary or otherwise to each individual athletes or organized sports association upon presentation of its sports program to be evaluated by the <u>BCSDC.</u>

SECTION 9. HALL OF FAME FOR BACOOR SPORTS. The Government shall establish a Hall of Fame for Bacoor Sports in honor and due recognition of athletes, both in the past and in the generations to come, who gave honor and glory for Bacoor during regional and national competitions by bringing home championship trophies and gold medals in their respective sports events.

SECTION 10. SPORTS FACILITIES, SUPPLIES AND EQUIPMENT: The Sangguniang Bayan upon the recommendation of the BCSDC shall appropriate funds for the purchase of adequate and sufficient facilities and equipments in order to meet the needs of intensive and safe participation of both in-school and out-of-school activities concerning sports.

SECTION 11. **CONTINUITY OF THE PROGRAM.** The Integrated Sports Development Program, as contained in this ordinance, shall continue to be in full force and effect unless otherwise repealed, amended, or modified accordingly".

SECTION 2. SEPARABILITY CLAUSE. Any provision of this ordinance found void by a court of competent jurisdiction shall not affect the rest of this Ordinance not affected by the said judicial finding of invalidity.
