A CITY ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 9, SERIES OF 2011, ENTITLED, "AN ORDINANCE MANDATING THE REGISTRATION OF ALL BICYCLES AND SIDECARS OPERATING IN BACOR, CAVITE."

WHEREAS, on 28 February 2011, the Sangguniang Bayan enacted Municipal Ordinance No. 9, Series of 2011, entitled, "A City Ordinance Amending Municipal Ordinance No. 9, Series of 2011, Entitled, "An Ordinance Mandating The Registration Of All Bicycles And Sidecars Operating In Bacoor, Cavite."

WHEREAS, there is a need to amend pertinent provisions of various municipal ordinances such as Municipal Ordinance No. 9-S-2011 pursuant to the ratification of Republic Act No. 10160 converting Bacoor into a component City of Cavite;

NOW, THEREFORE, during regular session assembled, upon motion of Councilor Edwin G. Gawaran duly seconded by Councilor Hernando C. Gutierrez **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod to amend various section of this Ordinance to read as follows, to wit:

Section 1. The following provisions of Municipal Ordinance No. 9, Series of 2011 are hereby amended and shall henceforth read as follows:

"Section 1: This Ordinance shall be known as the "Bicycle and Pedicab Registration Ordinance of the City of Bacoor".

Section 3: A registration fee of **Two Hundred Pesos (P200.00)** shall be charged against the owner/operator of a bicycle and/or sidecar covered by this ordinance. A registration fee of **One Hundred Pesos (P100.00)** shall be charged to the owner of bicycles or sidecars covered by this ordinance for the renewal of the said registration.

X X X X X

Section 5. PENALTIES. The Bacoor Traffic Management Office (BTMO) shall do the following within thirty (30) days after the approval of this ordinance by the **City Mayor**.

5.1 Submit a design of the above-mentioned registration plate to the BTFFRB and to the **City Mayor** which should be visible even at night and should be sturdy enough to resist the ravages of time, weather, and normal use;

5.2 Design the registration system/procedure to the BTFFRB;

5.3 Submit the registration system/procedure to the BTFFRB and to the **City Mayor**.

Section 6. The following penalties shall be imposed on anyone who violates this ordinance:

First Offense: community service consisting of street sweeping for **four (4) continuous hours**. The street/s to be swept shall be identified by the proper court of law.

Second Offense: community service consisting of street sweeping for **six (6) continuous hours**. The street/s to be swept shall be identified by the proper court of law.

Third Offense :confiscation of the bicycle or sidecar or both upon order of the proper court of law. Provided that the confiscated bicycle or sidecar shall only be returned after the owner thereof complies with this ordinance."

Section 4. Repealing Clause---Any ordinance in conflict with this Ordinance is hereby repealed and/or modified.
