APPROPRIATION ORDINANCE NO. 2013-5A

AN ORDINANCE RE-ALIGNING THE AMOUNT OF ONE MILLION PESOS (PHP 1,000,000.00) FROM THE "TRAINING EXPENSES" FOR THE PAYMENT OF EXPENSES TO BE INCURRED UNDER "GASOLINE, OIL AND LUBRICANT EXPENSES" UNDER THE BUDGET OF THE SANGGUNIANG PANLUNGSOD, CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2013.

WHEREAS, submitted for review and approval is the proposed re-alignment of funds under "Training Expenses" to "Gasoline, Oil and Lubricant Expenses" in the Office of the Sangguniang Panlungsod covered by the Annual Budget for Calendar Year 2013;

NOW THEREFORE, upon motion of Councilor Reynaldo Palabrica unanimously seconded by all the councilors present in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the re-alignment of funds under the Sangguniang Panlungsod's budget for "Training Expenses" to "Gasoline, Oil and Lubricant Expenses " as indicated above covered by Annual Budget for CY 2013.

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that :

Section 1. The purpose of this Ordinance is to appropriate the amount of One Million Pesos (PhP 1,000,000.00) for the "Gasoline, Oil and Lubricant Expenses" under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2013;

Section 2. The above-mentioned amount of One Million Pesos (PhP 1,000,000.00) shall be re-aligned from the "Training Expenses" under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2013;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;


Section 4. This Appropriation Ordinance shall take effect upon its approval.




