A RESOLUTION RECOMMENDING THE APPROVAL OF THE FOURTH AMENDATORY PROCUREMENT PLAN FOR BUDGET YEAR 2019

NOW, THEREFORE, after careful study, review, and deliberation of the matter, the BAC **RESOLVED** to recommend the approval of Amendatory Procurement Plan No. A-04-2019;

RESOLVED FURTHER, to furnish a copy of this resolution City Mayor Lani Mercado-Revilla for her information and approval.


